

ANNUAL REPORT OF THE PRESIDENT DELIVERED DURING THE ANNUAL GENERAL MEETING 25 NOVEMBER 2025

Dear Members

It is my privilege to present another year of SASEV activities on behalf of the SASEV Board. This report is for the period July 2024 to June 2025.

1. Membership

There are currently 288 SASEV members, two of which are international (one from Italy, the other from the United States of America). This year SASEV attracted 6 new members and there are currently 26 active honorary members and 2 honorary presidents, namely Mr Jan Booysen and Dr Ilse Trautmann.

2. Finances

SASEV is mainly dependent on membership fees, journal page fees (SAJEV), as well as the successful hosting of scientific knowledge transfer conferences, industry-relevant workshops, and sponsorships for its income. The organisation has once again managed to maintain a stable financial position over the past year, as reflected in the financial statements, although the year ended with a loss. I would like to express my sincere gratitude to all our members and especially our sponsors for their continued support during the past year, which has been financially challenging for many. We truly appreciate every contribution received.

Many thanks to our treasurer for the past term, Andries Daniels as well as Mina Lourens (Financial Administrative Officer) for administering the Association's funds. A special word of thanks to Mina Lourens for her dedication and efforts in the way she handled the finances of the Association.

3. SASEV Activities

3.1 MLF Workshop in partnership with Lallemand 9 October 2024, Klein Joostenberg

A workshop was presented that was aimed at winemakers to ensure the latest information related to MLF was presented. This included four presentations by two international and one local expert, as well as two wine tastings to showcase the impact of MLF on wine aroma and the potential faults associated with spontaneous MLF. The workshop was ended with Q&A session. The workshop had 46 attendees. Lallemand's contribution both financially and bringing out the international experts is acknowledged.
